- ➤ Reached out to TCH SOAR clinic a multidisciplinary clinic that follows up TCH Woodlands NICU patients. (high risk for sleep related death). Provided PowerPoint presentation, copy of the flyer with community specific data, and teaching so that the message in SOAR is the same as what is being modeled in TCH NICU.


